The board of directors of the Company (the "**Board**") would like to inform the shareholders of the Company (the "**Shareholders**") and potential investors that, based on the preliminary review of the unaudited management accounts of the Group for the six months ended 30 June 2023, the Group is expected to record a loss ranging from approximately RMB13.0 million to RMB15.0 million for the six months ended 30 June 2023, as compared with the profit of approximately RMB9.7 million for the same period of 2022. The loss is mainly attributable to the lower revenue resulted from the slower than expected recovery in the target market, the slowdown in project investment, the prolonged project implementation and payment cycle, as well as an increase in provisions for impairment of receivables out of the principle of prudence.

The information contained in this announcement is only based on a preliminary assessment by the Board based on the information currently available, including the unaudited consolidated management accounts of the Group for the six months ended 30 June 2023. Such information has not been audited by the Company's auditors, or confirmed or reviewed by the audit committee of the Company.
